Call to Order – Beryl Burnett

The Annual General Meeting of the Embroiderers' Association of Canada was held in Seventh Semester, Humber College, North Campus, Toronto, Ontario on May 18, 2016. EAC President, Beryl Burnett, warmly welcomed all attendees and invited EAC Course Manager Diane Scott to open the gathering with an Opening Thought.

Following the buffet meal, the meeting was called to order by President Beryl Burnett at 12:20 p.m. She congratulated the Seminar 2016 Committee on the excellent job they have done in organizing and presenting this Seminar. New Business:

Proposed Changes to EAC Bylaws - Dianna Thorne

The following changes to the EAC Bylaws were presented for a vote. To comply with the present EAC Bylaws, the following motion was made to table the vote on these changes until the 2017 AGM.

Motion 7: Marie Cron / Sue Thomas

That the following proposed changes to the EAC Bylaws be tabled to the 2017 AGM:

Under Section 3, the section on Affiliate Membership, to delete the phrase "which is already a member of another national or international association". The revised section is to read "Affiliate Membership, wherein the member is an institution, or group in which some or all members are not members of the Corporation".

Under Section 3, an addition of the following sentence be made - "Current Life Memberships will be honoured but no new applications will be accepted." This reflects current practice.

Under Section 8, the following two sentences to be added at the end - "The result of an electronic vote is as valid as if it had been passed at a regular Board meeting and is to be included in the records of the following meeting. Any member entitled to attend EAC meetings may request to attend an electronic meeting of the Board."

Under Section 17, clarification to be made by changing to the following wording - "The officers of the Corporation shall be a President, Vice President, Secretary and Treasurer and any such other officers as the Board of Directors may determine. The same person may hold any two (2) offices but only in unusual circumstances."

Under Section 34, clarification to be made by adding the word "annual" before "general meeting". The wording will then be the following - "The members shall at each annual general meeting appoint an accountant to review the accounts of the Corporation for report to the members at the next annual general meeting provided that the Board Member may fill any casual vacancy in the office of the accountant. The Board of Directors shall fix the remuneration of the accountant."

In May, 2015, the Board of the Embroiderers' Association of Canada, in response to questions and ideas brought to the Board about embracing bilingualism, passed a motion "That Association canadienne de broderie be registered as the official French name for Embroiderers' Association of Canada". That Association canadienne de broderie be registered as the French name for Embroiderers' Association of Canada and be added to the English name of our Association to create the official name of our Association.

News from the May 2016 EAC Board Meeting - Beryl Burnett

- Online voting for EAC positions has proved successful and will continue as we move forth.
- A Treasurer Consultant is being sought; please forward names to Joyce Gill.
- Investigation continues into how to correct damaged copies of <u>EC</u> being delivered to International members.
- EAC payment of shipping costs of EAC Library books both ways will continue until December 31, 2016.
- EAC nylon market / shopping bags were available at the cost of \$5.00 on site, \$6.50 if mailed.
- There was encouragement to participate in the Seminar Online Silent Auction.
- Machine embroidery thread was available free of charge on tables outside Seminar Central during Seminar 2016.

- Seminar attendees were encouraged to share their Seminar experience by posting photos on Facebook, using twitter and tweeting.
- The Archivist, Liz Scott, is working on a new Archives Policy which will soon be available.
- EAC is moving into digital storage of documents using Box.com.
- Approximately 3500 slides have been converted to digital format and are available on a compact disc from the EAC Library.
- It is projected that a new category, Group Entries, will be available for display in the Seminar Members' Exhibition.
- The new EAC website will be up and running in the next few weeks; both old and new sites will be running until the new site is completely functional.
- Updating continues on the Chapter Resource Manual.
- A promo for Seminar 2017 will be available on disk to all Guilds and will also be placed on the website as soon as possible.
- The Sampler Registrar hopes to have completed computer entry of existing Samplers in the next six months and will be ready then to ask for new submissions.
- EAC is in the process of developing a phased response to aid those who have been affected by the disastrous wild fires presently raging in and around Fort McMurray, Alberta. Stitching supplies for immediate use were collected at Seminar Central and more information will be forthcoming in how we all can reach out to help fellow Canadians at this time.

EAC Treasurer's Report - AGM May 2017

Grant Thornton completed the Review Engagement for the year ending August 31, 2016. These financial statements were distributed to all EAC members and also published in the Spring 2017 issue of *Embroidery Canada*. My comments are associated with the highlights.

For the year ending August 31, 2016, EAC showed a loss of \$3,733. This is down from the previous year income of \$8,740.

The primary reasons for the change are as follows:

Net revenue was down \$12,423 from the previous year. Income from Membership fees was reasonably stable. One of the significant differences is the lower Seminar profit.

Correspondence course revenue will continue to be variable. New initiatives in Education are being introduced and are expected to generate increased course awareness.

Expenses were marginally higher than the previous year. EAC continued to support the production costs of Project 150, and supported the donation of supplies to residents of Fort McMurray. These costs were funded by the Future Fund. The costs of *Embroidery Canada* and EAC programs remained about the same.

REPORTS EAC President's Report – AGM 2017

Our organization currently has 1537 members and 40 guilds across the country. The business of the organization continues to be conducted mainly through online meetings. The GoToMeeting system is used not only by the board but also by Virtual Threads, the Education Committee, the Web team, the Editorial Committee, Seminar 2017 and 18 and, for the first time, the Prairie-Pacific Regional Meeting.

Our ability to provide information to you our members was greatly enhanced with the launch of our new website in July. The new site is a Content

Management System and we no longer have to remember the assigned password but are able to create our own password. We also have eThreads, the blog and Facebook as ways to communicate with our members. The new Education Committee continues to offer us great new courses in a variety of formats. Those of us who don't have a needlework store in their area were pleased to see that some teachers now offer the option of having a kit included. Our creativity continues to be challenged with the ability to participate in several exchanges each year. This year it was a winter ornament and a scissors fob.

Under the capable leadership of Helen McCrindle, Project 150 has travelled across the country and many guilds took the opportunity to add their stitches to one of the beautiful panels. The panels are now (April 1, 2017) in Vancouver where it is being finished, cleaned and stretched. We are hoping that our dreams will come through and the Capital Commission will grant approval for the panels to be hung in Rideau Hall. I will update you at the AGM on May 17.

We continue to showcase our expertise and skills by participating in the many festivals across the country. Last year you could have found EAC represented at events in Truro, Toronto, Calgary, Surrey, and Vancouver. Thank you to our members who make this possible. For areas that don't have festivals many guilds showcase their skills by participating in local shows and other events. Don't forget that EAC has resources available for this purpose as well as our annual Stitch in Public Day.

We were saddened that the Fraser Valley Needlearts Guild made the decision to leave EAC but are encouraged that we have had inquiries about starting new guilds in other areas.

We offer our sincere thank you to Liz Scott,our long time archivist who is leaving her position. We wish her all the best for the future.

EAC Vice President's Report – AGM 2017

In every area under the vice president we have many new things transpiring. In Archives we are changing how we store most of our documents, Heritage is having to look at the size of our collection and our available storage of it, Library is purging out dated media with the hope of replacing them with new updated options and Samplers is getting it collection revamped and onto our website for all to enjoy. We have finalized our EAC presentation for guilds to use at any public events and it can be found on the website.

We are saying good bye to our archivist, Liz Scott after approximately 12 years of volunteering and welcoming a new appointee. Thanks so much Liz! **Archives – Liz Scott:** Archives hold historical papers and documents pertaining to events and history from our organization's past. All paper copies of archives are being scanned for ease of storing and finding documents when requested. The last remaining two filing cabinets have been emptied and sold to an EAC member. Remaining documents are now held in a couple of bankers' boxes. Separate files have been made for each Guilds' documents and for EAC's official documents i.e. Incorporation, etc. these will remain in paper and scanned format. The EAC Archives Policy and Job Description were reviewed and updated. By the end of the term all archival documents will have been reviewed and either destroyed, purged, or scanned as deemed applicable.

Heritage – Janice Routley: During the past year over 30 articles have been accessioned into the Collection, including: one of Dorita Grant's dolls, a jewelry box, a number of Ukrainian runners, a unfinished pillow cover (crewel) by Joyce Hunter, a lappet, lace hankies and many other items of interest. In March, a total of 6 people working at different times spent 3½ days going through the whole collection reorganizing and repacking. We have started to put together a small collection of baby bonnets which will soon be ready to go out on loan. All the information is on an Excel spread sheet which includes accession number, article name, name of box it is stored in, if it was inventoried in March/17 and appraised value if available. At this time there are over 1000 items in the collection.

Library – Isla Marsh: In the past year, EAC slides have been digitized. Copies of the DVDs are available. All commercial slides and videocassettes have been disposed of The offer of reimbursement of the return postage on books borrowed from the library has resulted in 24 book requests to date, which is encouraging. The one part of the goals for the year that has not been completed is the review of the library contents, The projected date was the end of March, but it will probably not be finished for another month, due to a number of unexpected interruptions.

Samplers – Anne Rowlands: Progress with the sampler registry, has been slow this year for various personal reasons, however, we are now exploring the possibility of connecting the registry to the EAC website. The connection of the registry to the website opens up many possibilities from academic research, to letting members know where they can visit samplers of interest in public collections across the country. The identification of samplers in

private collections will remain private, but the technical information about, and the photos of the samplers will be accessible.

This year we will distribute this information via e-mail and regular mail in a timely manner such that we comply with the notice period mandated in the By-Laws. This will give our members time to consider suggested changes prior to voting at the AGM meeting at Seminar 2017. Fall 2017 will occur in the same location, so if driving downtown Toronto was a deterent in the past, you don't have to worry. EAC is also planning on having a booth in shows at the Love to Sew Show, Vancouver (BC), Calgary, and Toronto, and increasing our presence at the Nova Scotia Fibre Festival to 5 days this year. Our international members are now receiving their *Embroidery Canada* magazine in a protective plastic covering. This will save our international members from receiving damaged or torn magazines. EAC Education Report – AGM 2017

Education is a key focus and deliverable to our EAC members. I have learned much since I joined the EAC Board officially on July 1, 2016 as the Education Director.

The Education Committee has grown and expanded with new people in existing roles and Carolyn Mitchell / Barbara Gilbert helping me learn the ropes and hopefully improve members' learning experience.

As a team, we have sourced new courses, added additional counsellors, refined the course process, and continue to update existing courses. We have launched a test student program for new courses to ensure the course content is workable and understandable for our members. Once they are ready for our members, the course is released for publication in our *Embroidery Canada* magazine, on the EAC website, in the EAC Blog and on eThreads. So watch for these additional learning opportunities.

Course Coordinator – Carolyn Mitchell: As this is a new position the learning curve and opportunities keep expanding and I am so pleased that each member of our team is willing to help the others when need be. My mandate is to find new courses in all three areas: Technique, Project and

Cyber Courses. I do this by approaching our competent teachers/authors as well as enlisting new teachers/authors encouraging them all to submit courses for consideration. Another part of this position is to maintain a Student Test List and assign students to test the various courses, who then return with comments on the courses. These comments are discussed with the authors and adjustments are made before pasting the courses over to the Course Manager and out to the membership.

Course Manager – Pat Armour: While a serious learning curve continues, correspondence courses continue to be formatted into a more consistent look and available as PDFs. The Blackwork Smalls as a Project Course (formerly Group Correspondence Course) as well as the Design for Embroidery Technique Study (formerly Individual Correspondence Course) have been completed. As skills improve, any courses that need tweaking will be revisited. Diane Scott set a high standard with her work in this role and I endeavor to keep to it.

Course Registrar – Arlene Chanel: Registration has been steadily increasing since September, 2016. Several new courses have been added with more forthcoming. Some of the older courses and new courses are being updated which has delayed the processing of registrations. Disclosure of any errors in any course is appreciated so that Education ensures the best quality of a course offered. To date there are 15 Technique Study courses (formerly Individual Correspondence Courses - ICC), 22 Project courses (formerly Group Correspondence Courses - GCC) and two Cyber courses being offered with the respective registrations completed: 11; 87; 17 + 15 pending as registration is still open, for a total of 130.

Youth Embroiderers Appointee – Linda Brenner: Youth Membership - We now have 63 Youth members as follows: National 8; Starfish Youth Stitchers, NL 23; Thread Whisperers, BC 5; Oceanside Youth Stitchers, BC 20; Tangled Threads, BC 6; Nifty Needlers, NB 1. Total Youth Members:63 *Eleanor Thomas Youth Award* – No applications were received in 2016. The next deadline is October 31st, 2017. Information about the award will be appearing in the next several issues of Youth Embroiderers' Newsletter. Youth Leaders will also be sent application forms and information about each category of the Award.

- Changes to EAC Bylaws - Beryl Burnett

The following changes will be voted on at the EAC Annual General Meeting at Seminar 2017. Please read and be prepared to vote at that meeting. If there are any questions please contact any member of the Board of Directors.

Motion: Beryl Burnett / _____

To accept the proposed changes in the Bylaws:

Under Section 3, the section on Affiliate Membership, to delete the phrase "which is already a member of another national or international association". The revised section is to read "Affiliate Membership, wherein the member is an institution, or group in which some or all members are not members of the Corporation".

Under Section 3, an addition of the following sentence be made - "Current Life Memberships will be honoured but no new applications will be accepted." This reflects current practice.

Under Section 8, the following two sentences to be added at the end - "The result of an electronic vote is as valid as if it had been passed at a regular Board meeting and is to be included in the records of the following meeting.

Any member entitled to attend EAC meetings may request to attend an electronic meeting of the Board."

Under Section 17, clarification to be made by changing to the following wording - "The officers of the Corporation shall be a President, Vice President, Secretary and Treasurer and any such other officers as the Board of Directors may determine. The same person may hold any two (2) offices but only in unusual circumstances."

Under Section 34, clarification to be made by adding the word "annual" before "general meeting". The wording will then be the following - "The members shall at each annual general meeting appoint an accountant to review the accounts of the Corporation for report to the members at the next annual general meeting provided that the Board Member may fill any casual vacancy in the office of the accountant. The Board of Directors shall fix the remuneration of the accountant."
